Grounds:

Overnight camping is not permitted at the site of the trial.

All vehicles must leave the Wildlife area by 10pm. A parking permit is required and may be purchased at the store on the Island at the foot of the bridge or at the 7-11 in Linnton. One day is \$10.00, annual is \$30.00.

Directions:

Take US Hwy. 30 (west from I-405 or US 30 bypass from I-5) to the Sauvie Island Bridge. After crossing bridge onto Sauvie Island, continue North on Sauvie Island Road for 8 miles.

After 8 miles, the paved road turns to gravel. Continue on the gravel road for another 2 miles. There will be a sharp right turn and you'll see the sign for the Crane Unit. Continue for another 1/4 mile and you will see the grounds and parking area on the left hand side of the road.



Permit:

Willamette Weimaraner Club has a permit to use the Crane Unit in the Sauvie Island Wildlife Area for Pointing Dog Field Trials. The permit allows for 2 judges, 1 bird planter and 1 marshal to be mounted. Only one vehicle may be on the field trial grounds inside the fence. Horse manure and all other waste must be removed.

During the trial you may train in the Wildlife Area outside of Crane Unit. To train anywhere on the Sauvie Island Wildlife Area you must have a free training permit that can be obtained at the ODF&W office during business hours. **Absolutely no horseback training allowed EVER.** Please be respectful of this fragile wildlife area. To support and safeguard our continued use of the Sauvie Island Wildlife Area for our sport please be mindful of the "leave no trace" principle.

COURSE AND BIRDS

All stakes are single course without a bird field. Chukar and/or quail will be released in all stakes except Open Puppy. A blank cartridge will be fired on bird contact in all stakes except Open Puppy.

The trial is being run as a flexible format trial and the club reserves the right to rearrange the running order of the stakes and add / rearrange judges if conditions warrant.

Horseback handling and/or scouting will not be permitted in any stake. AKC approved tracking collars will be permitted in all stakes. Entries are limited to the number of dogs that can be run from 07:00 AM to 6:00 PM on Friday. Entries will close when the maximum number of entries has been reached if this occurs prior to the specified closing time. We reserve the right to cancel any stake with fewer than 4 entries, and fees will be refunded.
